

## STANFORD UNIVERSITY SCHOOL OF EDUCATION MINOR IN EDUCATION PROGRAM PROPOSAL

The Stanford University School of Education (SUSE) requires the Minor Program Proposal to ensure that students have a plan to complete the minor that complies with both school and university policies. Any changes to the initial course of study planned while declaring the minor must be reflected on a revised program proposal. Revisions must be submitted on a new document, at least two quarters before the student intends to graduate (along with an updated Major-Minor Course Approval form).

### **MINOR REQUIREMENTS:**

You must take a minimum of 20 units to receive a minor in Education. The following constraints are placed on those 20 units:

- 1. All courses must be taken at Stanford University
- 2. A minimum of 6 courses are to be taken for a minimum of 3 units each
- 3. 3.0 GPA must be maintained for all courses applied toward the minor
- 4. All courses must be taken for a letter grade
- 5. Courses used to fulfill the minor requirements may not be used to fulfill any other department degree requirements (major or minor)
- 6. A maximum of 30 units may be applied to the minor in Education

#### **Core Course: 1 course required**

\* EDUC 101: *Introduction to Teaching and Learning* introduces foundational issues in teaching and learning, requires field observations in school sites, and is reading and writing intensive.

#### Foundational Courses: 2 courses required

\* Students must take at least two courses from this category. Please see list of pre-approved courses.

#### **Elective Courses: 3 courses required**

\* Students will select a subfield for their minor and take at least three electives within that subfield of study. Please see list of recommended subfields and electives.

#### Advising:

\* Meet with minor director on a quarterly basis to discuss opportunities at SUSE, course selection and progress toward completion of minor.

\* Contact the SUSE Undergraduate Programs Officer in Cubberley 141 if you have questions about declaring, enrolling in courses, graduation, and/or commencement.

#### **Additional Requirements:**

\*Apply for minor no later than second quarter of your junior year.

\*Declare minor in Axess by the final quarter of your junior year.
